- ▶ With a good position in their markets and a minimum turnover of 3.000.000 €
- Willing to increase their own resources via a capital increase, to strengthen their financial capacity in order to:

boost sales expand abroad merge and/or buy improve production systems create a new spin-off ...

Venture capital funds, corporate banking, "family offices" and other corporate investors interested in investing

500.000 € to 3.000.000 €

in already consolidated sme's with an important potential to expand and develop their activities.

### • Summary of the first previous 4 events

► <u>Ist Forum in Barcelona:</u>

13 companies presented a project Joint Turnover: 84 Mio euros Searching to raise: 28 Mio euros

2 signed agreements (1,7 and 2,0 Mio) and 2 else close to it (1,5 and 2,0 Mio)

► IInd Forum in Barcelona:

12 companies presented a project Joint Turnover: 58 Mio euros Searching to raise: 18 Mio euros

**III**rd Forum in Madrid:

12 compamies presented a project Joint Turnover: 60 Mio euros

Searching to raise: 22 Mio euros

► <u>IV th Forum in Barcelona:</u>

10 companies presented a project Joint Turnover: 52 Mio euros

Searching to raise: 21 Mio euros

- There are many Investment forums for Start-ups in Spain, but none for already consolidated companies. The Spanish SME needs to reinforce its future: increasing own resources, via capital increase or merger, is a very consistent way to achieve this objective.

- The SMEs must realize that the organizational structures of the company must be stronger in order to ensure their long-term possibilities. Only a larger size can make it possible.
